- **1. Agenda Approval** Hardin motioned to approve the agenda, Schantz seconded. Motion passed all ayes.
- 2. Audience Consideration none
- 3. Consent Agenda Kling motioned to approve, Schantz seconded. Motion passed all ayes
- **4. Insurance Policy Changes-** Ewart worked with Paul Horak, Horak Insurance to revisit what we have insurance on and what types of insurance are applied. Make sure that everything is covered with the right type and that the premium makes sense. Ewart asks if there are any objections from the Board. No objections
- 5. Release Bids for Shop Roof Repairs any work won't be done until the start of the FY. Sam Willson motioned to release bids for shop roof repairs. Schantz seconded. Motion passed all ayes.
- **6. Environmental Education Update** Field trip season is in full swing, 50 people attend Spring Break picnic in the park. Our EE program at Big Sand Mound helped to achieve the highest gold rating from the Wildlife Habitat Council. MPowerU HS students came to Langwood and completed paint work on the bird blind and helped ready fishing poles for the season. The low docks have been installed at LW. We added two afternoon camps for younger kids this summer plus another camp for 4-6th graders.
- 7. Maintenance Update Memorial benches have been installed at CB and two memorial trees have been planted at CB and VG. Water is on at all properties and all water tests are successful except for Snively and Flaming Prairie. LW Eagle Scout Project Bridge finished at Langwood. Campgrounds are whipped into shape and ready for the season. Luke is keeping up on the mowing by himself.
 - Maine Update on Complex Mowing bids for external mowing came back higher than if the county hired a part time mower/yardwork position. Maine will be recommending that the County hire a mower position which would loosely report to Ewart when out at the Complex.
