Black Hawk County Conservation Board approves, accepts and authorizes execution of Change Order #1 in the amount of \$6,200.00 to add painting of the replacement doors to the Rotary Reserve Replacement Windows, Siding & Doors Contract with Don Gardner Construction of Waterloo, IA, dated November 25, 2024. This change order will increase said contract from \$190,640.00 to \$196,840.00.

Change Order #2 is a no cost change order and will not increase or decrease the contract amount. Contract amount with Hudson Hardware will remain \$105,800.00 as adjusted by change order #1.
